ALL WEEKEND**

Format: 3 Riders constitutes a class, 3 Moto's & Finals or 4th Moto, Consolation Finals for classes with 10 or more riders (*not pro classes*), Olympic lane draws for gate positions in finals. **Racing will be under lights!**

Transponders: There will be a once only hire charge of \$10 for each transponder covering both Saturday and Sunday events and a charge of \$150 if a transponder is lost or not returned. There will be a refund of \$10 for any competitor with their own valid AMB ProChip transponder.

Transponders will be used for electronic lap timing. It is the rider's responsibility to ensure that the transponder is correctly fitted to their bike. Transponders must be returned to the Race Director at the conclusion of the event/s and failure to do so will incur a cost to the rider of \$150 plus costs.

Class 7 Event to be run to UCI BMX rules, with Australian Regional applications.

TRANSPONDERS MUST BE RETURNED TO THE RACE ORGANISER AT THE CONCLUSION OF THE EVENT AND FAILURE TO DO SO WILL INCUR A COST TO THE RIDER OF \$150 PLUS COSTS.
